R4 000.00 for building/area from 0m ² to 100 m ² plus R600 for every increase of 50 m ² coverage		
Business Use		
R6 000.00 for building/area from 0 m ² to 100 m ² plus R750 for every increase of 50 m ² coverage		
Industrial Use		
R7 000.00 for building/area from 0 m ² to 100 m ² plus R1000.00 for every increase of 50 m ² coverage		
Institutional Use		
R5 000.00 for building/area from 0 m ² to 100 m ² plus R700 for every increase of 50 m ²		
Agricultural Use		
R5 000.00 for building/area from 0m ² to 100m plus R800 for every increase of 50 m ² coverage		
Mining Use		
R10 000.00 for Building/area from 0 m ² to 100 m ² plus R1500.00 for every increase of 50 m ² coverage		
Any other use that the Municipality may determine as an illegal use of land		
R5 000.00 for building from 0m ² to 100 m ² plus R700 for every increase of 50 m ² coverage		
Continuation of illegal land use activity in contravention of a notice counted on each day from the date of the first notice. (R100 Per day)
